The other usual ZIFA grants (Forward 2.0) will be used as per the FIFA Forward 2.0 template.

All recipients save for individuals paid directly by ZIFA HQ must acquit and provide to ZIFA, evidence of such disbursements through a detailed statement and of such payments and transfer copies.

Until full utilisation of the proceeds, the recipient must send such statement of acquittals by the 7th of each preceeding month without fail.

ZIFA finance department or its chosen auditors can institute spot checks and audits at any time to any beneficiaries save for individuals.

Only individuals beneficiaries paid directly by ZIFA do not need to acquit as final end user.

The budget has been prepared in USD\$. The prevailing official interbank rate as given by the banks will be used at time of disbursements.

The contigent balance of USD\$ unallocated is meant to cover unanticipated urgent areas which may require intervention in the near future.
